

Official Rules for Dunn-Edwards “Which Decade Are You?” Giveaway

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS GIVEAWAY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **General:** Participation in the "Which Decade Are You?" Giveaway constitutes the entrant’s full and unconditional agreement to these Official Rules.

4. **Eligibility:** The "Which Decade Are You?" Giveaway (“Giveaway”) is open only to U.S. residents. Entrants must be at least twenty-one (21) years of age or older at the time of entry. All employees, sales representatives, licensees, or agents of Sponsor or any of its affiliates (collectively, “Sponsor Persons”); the immediate family members (spouse, parent, child, sibling, and their respective spouses) of any Sponsor Person; and all persons living in the same households as any Sponsor Person (whether legally related or not), are not eligible to enter. All applicable federal, state, and local laws and regulations apply. Void where prohibited by law.

5. Entry Period and Limit:

Each entrant may enter one (1) time only during the “Entry Period”. All entries become the exclusive property of Sponsor, and none will be acknowledged or returned. Any attempt by any entrant to obtain more than one (1) entry by using multiple/different identities,

registrations, or any other methods will void that entrant's entries, and that entrant may be disqualified.

6. How to Enter: There is one way to enter the "Which Decade Are You?" Giveaway during the Entry Period:

A. (i) Complete the "Which Decade Are You?" quiz available on <https://dunn-edwards.involve.me/colors-of-the-decades>, and (ii) then opt-in to email marketing from Dunn-Edwards at the end of the quiz.

Each entrant will automatically be entered for a chance to win the "Grand Prize" or "Second Place Prize".

The required information to complete the entry form is to provide your name, email address, and check the box to opt-in to receive promotional email messages.

By completing the entry form, you agree to (i) receive promotional email messages and (ii) these Giveaway Official Rules. You may opt out of email messages at any point.

7. Selection and Redemption: No later than Monday, March 9, 2026, Sponsor will randomly select one (1) winner from among the eligible participating entrants to receive the Grand Prize and one (1) winner from among the eligible participating entrants to receive the "Second Place Prize". Upon verification of eligibility, winners will be notified by email no later than Monday, March 9, 2026. The winners must accept their prize within 5 business days after being notified by providing their mailing address to the Sponsor. If the initial winner(s) fails to accept the Grand Prize within the specified deadlines referenced above, the initial winner(s) will forfeit the prize and a new winner(s) will be promptly drawn from the eligible entrants and subject to the same deadlines and other terms and conditions of these Official Rules, with this process continuing until Friday, April 3, 2026. After such date, if the Grand Prize and/or the Second Place Prize is still unclaimed it will be returned to Sponsor.
